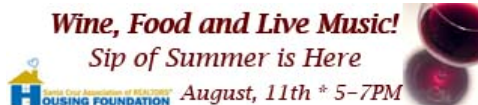

Code of Ethics Article 3: Cooperation and Changing Compensation

A common dispute between REALTORS® surrounds the situation where a listing broker states a commission percentage for the cooperating broker in the Multiple Listing Service (MLS), but writes a lower percentage in one of the forms used for the transaction (like a Counteroffer or Purchase Agreement). This maneuver puts the cooperating broker in the uncomfortable position of having to choose between two unpleasant options: He or she can accept a smaller commission than was originally offered in the MLS or risk interfering with the deal for his/her client by objecting to the commission. Of course, if the cooperating broker wishes to agree to a smaller commission, that is OK. On the other hand, click [here](#) to read more
