Time is Running Out! Census Deadline is Sept. 30

As you know, the Census is important. Every uncounted person translates into a loss of \$2,000 in revenue per year over 10 years. Over the next decade, even a 5% undercount means \$272 million in lost funding. With less than two weeks to go, the Santa Cruz County Census Complete Count Committee is continuing to ramp up outreach efforts in an effort to make sure all community members are counted.

The deadline for the Census is Sept. 30. It can be filled out online at <u>2020Census.gov</u> or by phone using 844-330-2020. Santa Cruz County is currently at a 70.4% self-response rate, which is great, but there is room to grow!
