3. I am aware that participation as a volunteer may require periods of standing, bending, lifting and carrying up to 40 pounds and will require the exercise of reasonable care to avoid injury. I am voluntarily participating in this activity with knowledge of the hazards and potential dangers involved, and agree to accept any and all risks of personal injury and property damage.

As consideration for volunteering for Grey Bears, I hereby agree that I, and my assignees, heirs, guardians and legal representatives, will not make a claim against or sue Grey Bears or its employees, agents or contractors for injury or damage resulting from the negligence, whether active or passive, or other acts, however caused, by any of its officers, employees, agents, or contractors of Grey Bears as a result of my volunteering. I hereby release and discharge Grey Bears and its officers, employees, agents and contractors from all actions, claims or demands that I, my heirs, guardians and legal representatives now have, or may have in the future, for injury or damage resulting from my participation as a volunteer.
5. I understand that if I am injured or become ill in the course of volunteering, I authorize Grey Bears to seek emergency medical treatment on my behalf in case of injury, accident or illness.
6. I understand that the materials and tools provided by Grey Bears are and remain the property of Grey Bears, and I agree to return these tools and any materials to Grey Bears at the end of my volunteer service.

I authorize Grey Bears to use my photograph, personal story or appearance in an organization video to further the Grey Bears mission to improve the health and wellbeing of seniors through volunteerism and community participation. I understand that my photograph, personal story or appearance in an organization video may be used in a variety of promotional materials including newsletters, flyers, brochures, advertisements, fundraising letters, annual reports, websites, social networking and other print/digital media.
